Sub: Capacity building of Engineers of Government departments for implementation of Energy conservation programmes – request for waiving of the examination fee for the government sector candidates – reg.

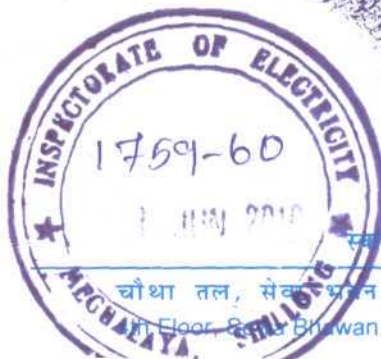
Dear Madam,

Please refer to your D.O. No.569 of 30th April 2010 on the above subject addressed to DG,BEE. The Bureau appreciates your proposed initiative of strengthening the energy management capabilities of government officials by encouraging them to write the National Certification Examination, conducted by BEE.

In this connection, we are pleased to inform you that the competent authority at BEE has approved the following:

1. The State Designated Agency, established under the Energy Conservation Act 2001, may nominate up to 5 officials for 11th National Certification Examination (proposed to be conducted in December,2010) and subsequent examinations, from the State Government & Central Government Departments functioning within the concerned State/UT. The nominated officials shall meet the eligibility criteria of the National Certification Examination for Energy Managers and Energy Auditors. These officials will be allowed to take the certification examination conducted by BEE, without paying any Registration and Examination fee. However, this waiver is applicable for the fresh candidates only and not for the supplementary papers written by such candidates in the subsequent examinations.
2. The selection criteria for selection of such officials may be finalized by SDA keeping in view about their State/ UT requirements , and a copy of the same may be forwarded to BEE
3. The left over quota of one State/UT of one examination can not be carried forward to the subsequent examinations.
4. BEE will not meet any cost towards preparatory training course conducted either by SDA or any other agencies.
5. The above will remain in force till further notice/order issued by BEE

As an one time measure, the 5 additional eligible officials from each State/UT, nominated by SDAs, already registered in the previous Certification examinations prior to the 10th Certification examination , and having Supplementary in one or more papers, may take 10th Examination without paying any Supplementary fee. These nominated supplementary candidates may register by 25th June, 2010 for the 10th Examination. The fee exemption is being granted for such candidates as this is the only chance left for such candidates to write the certification examination on old syllabus basis. This fee waiver will not be applicable for such supplementary candidates for the 11th Certification and subsequent examinations.

Last date for On-line Registration and submission of Application is: **25th June 2010** (only for those of the supplementary & up-gradation candidates, who were unable to register for the April 2010 examination).



8. The SDAs may forward the nominations directly to the National Productivity Council, Chennai, with a copy to Secretary, BEE

We hope that the above initiative taken by BEE would encourage the officials of State Governments to take up Energy Management programmes and projects in their respective departments.
